### WRITING FROM THE NEW WORLD

**January 1st 2025. London**

Usually I would write with co-contributors, however such is the urgency of this situation I dare not coordinate them.

This special edition is a diary of sorts of my view of events and how we've found ourselves here: Electricity is now rationed to one hour per day – sometimes none. People's savings have been wiped out and cash banknotes and coins have been forbidden and replaced with state management of all EFT's (Electronic Financial Transactions) which we spend our meagre weekly allowance on.

I recently came across my notes from 2013 and have used them to prepare a timeline of sorts over the next couple of pages which outlines the fall of our society into the state we find ourselves in now. Since the new rules were introduced to restrict the right to free speech it's been difficult to legally distribute this paper. Recently State Officers have set up a new station on the National Barrier which runs across the road from the building which houses this basement press and I can't pass copies to my contacts to distribute like before – they won't make it past the barrier without inspection.

I don't know who will read this issue but I suppose I will keep a copy hidden somewhere in the hope that when peacetime returns and history is re-written the timeline will provide a future reader with a more authentic testimony of the events that led to the attack.



### AFTER THE ATTACK

Once it hit and the full extent of the devastation was revealed the people in the Eagle state by the sea thought their way of life was over – the airborne army of the Bear had seen to it that liberty had fallen and the task of rebuilding what was lost seemed too difficult. However, the people underestimated their President.

Before the attack, no-one dared speak of the likely outcome of the provocations made by the Administration towards the nation of the Bear. In the aftermath, the Administration removed the personal freedoms the country had fought so hard for with one hand whilst delivering rousing speeches with the other.

The Commander-in-Chief rallied the nation and gave them back their pride and spirit. He made them believe anything was possible. The newswires showed how he expertly weaved courage and patriotism through every breath he took and every word that flowed. He was ready to rebuild, were they?

### BRITAIN LEADS THE WORLD

The British Prime Minister was appointed leader of the 'New World Government' for the remaining three and a half years of his term in office and populations from across the western world were amazed at his ability to lead the international rebuilding effort.

It seems he was chosen because of his parties' strong links with the banks - after all London was the financial capital of the world and the empire of the British Lion roared ahead as the lead voice in the international re-financing programme. Financial leadership ability was a huge asset in this new world.

The people seemed to idolise the new regime – at first.

They were amazed at the speed with which the western world recovered from the devastation. The new financing programme to rebuild the national infrastructure of the Eagle state damaged by the attack was swiftly implemented, elimination of cash and electronic state management of funds soon followed and a 'new peace' was

smoothly introduced.

New 'security' measures including cold-war style monitoring and reporting of all conversations held in public – and private were implemented almost overnight.

There seemed to be a monitor on every street corner.

At first people seemed happy to have dissenters of the new regime treated as potential terrorists – everybody wanted 'justice' for the damage done to the Eagle state and the financial restrictions we all had to suffer as a consequence.

It didn't matter that those who spoke out were British citizens with no connection to the hostile nation – the government had made it clear that all dissenters were potential terror threats in the new world and the people seemed happy to agree.

Their state of fear and frustration was easily exploited and re-directed by the new regime communications office which in this age of restricted communication had become the key source of all 'news'.

Yes, I do recall people being happy at first.

Even after they saw their savings and earnings replaced with a single weekly state assistance payment there was admiration at how the government had 'saved' the international economy from collapsing with these measures.

Slowly, the same citizens who previously cheered the One World Government found themselves in a new world which doesn't discriminate between 'terrorists' and ordinary people. As the government can't actually tell who is likely to pose a terror threat they explained that they would have to implement new measures which would put the whole population under restrictions.

They did explain it was for our protection and that those with nothing to hide had nothing to fear. In the aftermath of the total devastation that happened to the state by the sea, we thought these 'emergency' measures seemed reasonable.

Several years' later with the 'emergency' measures still in place, people are getting agitated about being constantly surveiled and monitored as if they themselves are the threat. There is a slow realisation that the government seems to have no intention of repealing these measures and our freedoms have been limited forever.

Not only are our conversations and correspondence heavily monitored, the EFT rules and financial restrictions on what we can buy or sell without government authorisation are getting more prohibitive.

I heard that the baker from round the corner tried to place an order for a special kind of baking powder and received a visit from the Special Officers – apparently that type of powder could be used to make a bomb. People are getting very fed up with the restrictions to what we can order for food – the range of goods is getting smaller because the government is demanding a higher transaction percentage from the suppliers.

### **THE CASHLESS SOCIETY**

Last year electronic payment cards were withdrawn and we were all made to suffer the forced implementation of 'ID chips' in one of our hands so that our financial details cannot be swapped or traded and - for our protection – it also ensures that we can be identified at all times. This means that potential terrorists have nowhere to hide.

The pain of the 'chipping' has died down but the uneasy feeling of knowing that you have been 'chipped' remains. Apparently there is a trial for putting some sort of chip in people's eyes so they can have eye scans – it seems the government believes eye chipping to be more secure as people will be reluctant to remove an eye chip in the way they remove and reprogram hand chips.

Even people who wouldn't normally be called 'dissenters' have found themselves on the wrong side of this new order. The middle class have found themselves being treated like terrorists for uttering a single word of complaint about the chips, the curfews or any other aspect of the new regime or how it makes life difficult for them and their children.

Teachers are being particularly closely monitored for what they are 'teaching' their pupils about how we ended up in this new world.

I am also hearing whispers questioning the 'effortless' convenience and speed with which the New World Government has been able to get up and running again in the face of the devastating surprise attack.

People are starting to think the unthinkable – some are saying that it seems *almost* like the new government and EFT system had been planned and those in power were just...waiting for the right opportunity to force this new way of life upon us.

When people ask how Britain ended up in a totalitarian government there are lots of different answers but I think it all links back to one key thing – when the Human Rights Act which protected our freedoms was scrapped all those years ago.

I guess sometimes, we don't know what we've got until it's gone.

## **TIMELINE OF KEY EVENTS**

### **2013**

This publication publishes its third issue entitled 'Has Obama been corrupted by the Machine'. It includes interviews with a government whistleblower and leading human rights leaders and warns about the impact of encroaching government powers and plans by the British Conservative party to scrap the Human Rights Act.

### **2014**

The Russian military intervention in Ukraine sees tensions flair up across all sides of the Atlantic and tough economic sanctions imposed on Russia by the United States, European Union and other countries and international organisations.

The Russian currency tumbles to a record low against the dollar.

The 1958 UK-US Mutual Defence Agreement (MDA) has been updated to "permit the transfer between the United States and the United Kingdom of classified information concerning atomic weapons; nuclear technology and controlled nuclear information; material and equipment for the development of defense plans"

The British press start reporting on Russian military jets flying near British airspace.

### **2015**

#### **January**

More press reports of Russian military jets flying near British airspace.

#### **April**

A World Bank report highlights that 5 million more Russians will be pushed into poverty due to the economic sanctions.

#### **May**

Russia publishes a long list of European diplomats and politicians banned from entering the country. The list includes the previous British Deputy Prime Minister.

#### **June**

The US announced plans to expand its military presence in NATO states in Eastern Europe.

The Russian President announced plans to boost the Russian nuclear arsenal with 40 missiles in response to the US plans for an increased military presence in Europe.

## **TIMELINE OF KEY EVENTS**

### **June 2015 Continued...**

A BBC news report highlights that some Russians are fleeing the country due to fears of an attack by the US, or due to concerns that the Russian President will be placed under pressure to launch a pre-emptive attack first.

The British Foreign Secretary discussed the potential implications of hosting American military cruise missiles on British soil stating it would be unwise to make “unnecessary provocations” as Russia already has a “sense of being under attack”.

The US announces a full scale criminal investigation into corruption within FIFA. The Russian President makes it clear he views this as a hostile action as the American investigation may result in the 2018 World Cup being taken from Russia.

It was announced that Rothschild were advising the British government on the sale of the final government stake in the Post Office. The appointment of this secretive financial institution whose name has such close links to the provision of wartime finance took place just before the ‘event’ happened - putting them in the perfect position to advise the government on how to structure the new economic system during the crisis.

### **July**

Greek voters rejected bailout plans following a national referendum raising fears of a financial crisis in the Eurozone.

### **The Dark Winter of 2015**

A "Planned Event" took place which set the scene for the next 12 months of escalating tensions. This numerical event sent a shockwave across both sides of the pond.

### **2016 – 2017**

The US and Russian Presidential elections take place with both leaders determined to guard their legacy in the face of rising international tensions.

## **THE BIG EVENT**

### **2017 – 2020**

I don't remember when exactly as no-one likes to remember the day but around this time the ‘Big Event’ happened.

During this time the British Prime Minister rushed through a law which overturned the Human Rights Act.

Electricity was rationed to one hour per day.

## **2020 A NEW ECONOMY**

After the event triggered a new global financial crisis the government froze the assets of each British Citizen and made cash payments illegal. The electronic state management of funds was meant to stop terrorists from financing their operations but we all suffered.

The government are starting to lose control. All their new powers don't mean anything when people are fed up with living on rations with minimal access to electricity. People are starting to realise that there is only one state guard for every 100 citizens. If the government divert military resources away from the border to help manage the peace with ordinary civilians then the hostiles will strike in the unguarded areas.

I hope the government lift these restrictions otherwise it looks like a new war is coming – and this time, no-one will be safe.
